## CUSTOMER INFORMATION

Dear Sir or Madam,

Given the current circumstances, we are writing to inform you about the impacts of the coronavirus and the measures being taken in the BLÄSSINGER GROUP.

To contain the further spread of the coronavirus, we have informed our employees in detail about **hygiene measures, rules of conduct** and other **operational measures** in place at our company. **Every individual is urged to avoid possible risks and chains of infection.** Both external and internal business trips and visits have been reduced to a minimum.

### Concerning our service level:

The tasks and activities of our Sales and Customer Service departments and other administrative departments can also be carried out by employees working from home in accordance with our emergency plan. The technical conditions required are in place and some employees are already using this option.

Both our **Logistics Centre** at our head office in Ostfildern (Germany) and our warehouses in different locations contain normal stock levels. These warehouses can represent each other in the case of quarantine. A small back-up team can additionally ensure access to the stock. In case of emergency, the logistics routes of the different branches can be mutually rerouted.

At present, we are unaware of any unusual delays to deliveries from our supply partners.

**The situation in China:** Deliveries from China are slightly delayed due to the factory closures implemented after the Chinese New Year. Nevertheless, work in the factories has now returned to usual. The logistics company Schenker is supplying goods from China as normal and all deliveries have been dispatched and are currently on their way to our company.

**The situation in Italy:** According to our suppliers, production activities and work are continuing as usual. The problem here is the hauliers, most of which are no longer travelling to Italy. We are currently unable to foresee further developments (checks, border closures, factory closures, etc.) with regard to Italy.

**The situation in Europe and the rest of the world:** At present, we are unaware of any limitations. We are, however, unable to foresee further developments. The current situation is changing on a daily basis. We assure you that we are doing everything possible to guarantee the smooth processing and completion of your orders.
